Beliau telah bergabung di Baramulti Group sejak tahun 2011 hingga saat ini sebagai Advisor, dan tengah menjabat sebagai Komisaris Utama di Entitas Anak Perseroan PT Antang Gunung Meratus (AGM). Beliau juga pernah menjabat sebagai Direktur Utama AGM (2011-2014). Selain itu, Beliau pernah menjabat sebagai Tenaga Ahli Kepala Badan Intelijen Nasional (BIN) yang dahulu bernama Badan Intelijen Negara (2007-2013), Staf khusus Kepala BIN (2005-2007), Staf ahli Menteri Energi dan Sumber Daya Mineral (ESDM) (1998-2006), serta pernah bertugas di Badan Intelijen Strategis ABRI sebagai Paban, Komandan Satuan Intelijen, dan Direktur (1990-1995).

Slamet Singgih is Indonesian Citizen, 75 years old. He finishing National Military Academy in 1965 at Magelang, SESKOAD in 1981 and LEMHANAS in 1994.

He joined Baramulti Group since 2011 till present as an Advisor and has served as a President Commissioner at the Company's subsidiary, PT Antang Gunung Meratus (AGM). He is also had served as President Director at AGM (2011-2014).
